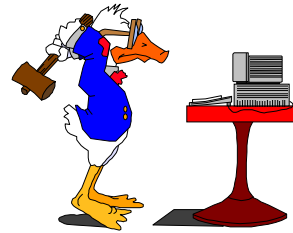

provide information and assistance to other members based on their history of service to the Club.




